



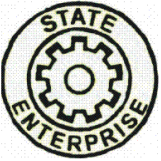

1. Open Tenders are invited by National Fertilizer Marketing Limited, established in 1976 as a subsidiary of NFC working under administrative control of MOI&P. The Company is solely responsible for Marketing and Distribution of Imported Urea throughout Pakistan. Tenders are invited by National Fertilizer Marketing Limited, Lahore from the experienced, capable and financially sound **Manpower and Security Contractors** duly registered with income tax and sales tax department against the refundable **Bid Security** amount **Rupees Fifty Thousand Only (Rs.50,000/-)** as per clause 25 of PPRA rules, that has to be deposited by each bidder along with their bid in the form of Demand Draft/Pay Order in the name of NFML, payable at Lahore.

Tender documents containing Delivery Time/Completion Schedule, Qualification Criteria, Evaluation Criteria and Terms/Conditions of Contracts, Integrity Pact, Power of Attorney and Affidavit for not having been Blacklisted/Barred/Defaulted which can be collected against the Demand Draft/Pay Order of **Rupees Three Hundred Only (Rs.300/- Non Refundable)** during Office hours from NFML Head Office located at 53-Jail Road, Lahore, on any working day during office hours till **Tuesday December 24th 2019 before 05:00 PM** which must be submitted on **Thursday December 26th 2019**, till **10:30 AM**, that shall be opened on the same day at **11:00 AM**, by the designated committee and the representatives of the interested parties, who wish to attend. The existing and other interested parties are requested to submit their company profile with all relevant documents, according to the “**NFML Tender Documents for Award of Manpower/Security Contract**” After necessary scrutiny of documents, evaluation by the competent committee and the approval of the NFC/NFML competent authority, the successful/unsuccessful parties will be informed through letters. The successful bidder has to deposit performance amount Rupees One Million Only (Rs.1,000,000/-) before signing the contract agreement in the form of Demand Draft/Pay Order in the name of NFML, payable at Lahore as per clause 39 of PPRA rules.

The bidders are informed to quote “**MINIMUM SERVICE CHARGES %**” inclusive of all Taxes applicable in the country on the given fixed wages and have to abide by all laws in place i.e. Federal/Provincial (Labour Laws etc)/Local Laws/statutes as well as Government notifications from time to time. Moreover, applicants are required to furnish proof of performance during last three financial years.
