The Company is solely responsible for Marketing and Distribution of Imported Urea throughout Pakistan. The tenders are invited from Security Services contractors registered with income tax and sales tax department for **SIX (06) NFML BULK STORES** (for a period of Seven (07) months-extendable) effective from **1<sup>st</sup> February, 2021 till 31<sup>st</sup> August, 2021** against *refundable Bid Security* amount equal to 5% of the total bid value quoted for all services at each store as given at clause-25 of PPRA rules-2004, which has to be deposited by each contractor in the form of Demand Draft/Pay Order in the name of NFML payable at Lahore. The Security contractor is responsible for safety of the store. The 10% refundable Performance Guarantee for Seven (07) Months shall be deposited by the successful bidder in form of Demand Draft/Pay Order, in the name of NFML, Lahore before signing of agreement. 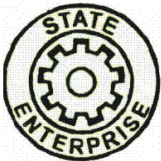
