



**NATIONAL FERTILIZER MARKETING LIMITED,

TENDER FOR LABOUR-CUM-SECURITY CONTRACTOR
AT NFML BULK STORES ELECTRONICALLY
THROUGH FEDERAL E-PADS PORTAL**

National Fertilizer Marketing Limited (NFML) invites "Single Stage-One Envelope procedure" Tender for a Labour-cum-Security Contractors through e-PADS for handling of fertilizer bags and provision of security guards / watchmen, registered with Income Tax and Provincial/Sales Tax Department for two (02) NFML bulk Stores (for a period of Twelve (12) months-extendable) effective from the date of signing of agreement. As per clause 25 of PPRA Rules, Demand Draft/Pay Order in favor of NFML, fixed Bid Security amount (Refundable) including of all Government taxes be sent through e-PADS, while the original fixed bid security must be dispatched to the undersigned by each participant before the opening of tender. The Labour-cum-Security contractor is responsible for Unloading from Railway Wagons/Trucks and stacking in store, loading into trucks, Truck to truck loading, Re-processing, Unstacking, Hammering, Re-bagging, Weighing, Stitching, Re-stacking and security & safety of the fertilizer stock and all assets. The contract is to be awarded to a single winning lowest party i.e. Single Labour-cum-Security Contractor at each NFML bulk store, having quoted the lowest total rates for all services. The 10% refundable Performance Guarantee for Twelve (12) Months (including fixed bid money for instant tender) shall have to be deposited by the successful bidder in the form of Demand Draft/Pay Order, in the name of NFML, Lahore before signing of agreement. However, previous bid money, security/performance guarantee and the pending payments shall not be entertained in this fresh tender. One party can participate for maximum two NFML Bulk Stores only. Manual bids shall not be accepted. The details are as under: -

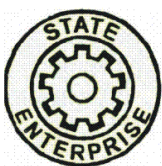

Tender documents containing Fixed Bid Security amount, Delivery Time/Completion Schedule, Qualification Criteria, Evaluation Criteria and Terms/Conditions of Contracts which can be downloaded from NFML website and e-PADS against tender documents fee in shape of Demand Draft/Pay Order of *Rupees Ten Thousand Only for each store (Rs.10,000/- Non Refundable)* in the name of NFML, a scanned copy of which be sent through e-PADS while the original must be dispatched to the undersigned before the opening of tender. Without receipt of original Demand Draft/Pay Orders against tender documents fee and fixed bid security, the bids shall not be accepted.

The employees, their spouse, Cartage Contractors and the dealers of NFML are not eligible to apply. All Tenders can be uploaded through e-PADS latest by 11:00 A.M on Thursday the 23rd October, 2025, which shall be opened by the designated committee at 11:30 A.M the same day.

National Fertilizer Marketing Limited may reject all bids or proposals at any time prior to the acceptance of a bid or proposal in accordance to clause 33(1) of PPRA Rules-2004.
